In case it is helpful, I am attaching a great historical tracing of the GMDO that Victoria laid out, but it is not necessary to review if that feels too overwhelming (I recognize there is a lot of content here and people have busy lives). It is pasted below and attachments are also attached:

When Ivan first passed away, we weren't sure the GMDO or GMDS was going to continue. At all.

After a few months, when Fearn decided to continue, a group of us formed to support her in handling all-the-things. We called it a counsel.

We supported one another and Fearn and figured out along the way what the structure and purposes of the council were.

There's some good/ useful stuff in all of that that may help our current council, so I've included the structure & purpose of the previous council below. It's a PDF titled GMDO Council Roles & Responsibilities

After over a year, the council disbanded. Those who remained on the board for Dreamland sanctuary continued to meet, but the rest fell away into more individual tasks &/ or onto Fearn again.

Attached is also the most updated version I can find in my computer for the Code of Conduct. This document is supposed to be signed by every student before they initiate as Bards. I'm not sure if the home study students have ever seen it. This talks about the structure & overlap between the school, community, and dreamland as it has been as well as lays out community agreements regarding behavior, communication & conflict resolution. I'm sharing this in case everyone in our current council hasn't read it. It also has a mission statement.

It's attached as a pdf below titled GMDO COC Final April 2017. (I KNOW there's more recent versions, I just can't find them).

The fourth attachment is the "Jenky" rubric of a proposed structure I've designed for the GMDO and the GMDS with descriptions of responsibilities of each role. I offer it as a starting place for the purpose of moving forward with ideas of structure with more ease. I'm not sure if I've plugged in everything that Fearn did yet, but it's a good start. I recognize things will likely need to be added or subtracted and fleshed out more. From a legal perspective I suspect it's best for the GMDO & GMDS to be one legal structure with the GMDS being within the GMDO.
